SS Shieldhall was built in the 1950s on classic lines and plied the Clyde working for Glasgow Corporation. At the end of her working life she was saved by an Historic Ships Preservation Society (member and former President of Holborn Law Society David Morgan is a trustee); she is maintained largely by volunteers and enthusiasts and earns her keep on day excursions and events. There will be opportunities to see around the ship, from the engine room to the bridge, which does not happen a Caribbean cruise!
